4. A brief analysis of the dissertations considered by the council during the reporting year, highlighting the following sections:

According to the dissertation of Almagul Zhakanovna Kalykbaeva:

1) analysis of the topics of the reviewed works;

The topic of the dissertation is "Organization of self-assessment of educational achievements of students with mental retardation in inclusive education."

The defense took place on June 13, 2022.

new and reliable results were obtained in the work:

- There is insufficient scientific data on the features of assessment and self-assessment of students with mental retardation. A detailed analysis of modern scientific research on the assessment and self-assessment of children with mental retardation should be presented;
- the scientific data on self-assessment of educational achievements of normotypical students in primary school are summarized. But there is no

scientific data on the features of self-assessment of students with mental retardation, and there is also no analysis of modern research on the assessment and self-assessment of children with mental retardation in the conditions of their joint education with normotypic peers, that is, in inclusive education.

- some features of self-assessment of educational achievements of primary school students are revealed. However, the relationship between the formation of self-assessment skills and adequate self-esteem in students with mental retardation, put forward by the dissertation as a scientific hypothesis, is insufficiently substantiated.:
- A "Model of the formation of the skill of self-assessment of educational achievements of primary school students based on the principles of SMART and Bloom's taxonomy in inclusive education" has been developed. However, the model does not specify the methodological approaches on the basis of which the model is built, and also does not sufficiently reflect the logic of interaction and the existing relationships of the modeling subject, the modeling subject and the educational environment in which all participants in the pedagogical process interact. Along with this, the model does not clearly reflect the practical application of the principles of SMART and Bloom's taxonomy (except for the indication of them in the "Methods").
 - 2) the connection of the topic of the dissertation with the directions of the development of science, which were formed by the Higher Scientific and Technical Commission under the Government of the Republic of Kazakhstan in accordance with paragraph 3 of Article 18 of the Law "On Science" and (or) state programs;

3) analysis of the level of implementation of the results of dissertations in practice

However, the provision submitted for protection, which involves the development of a system of special tasks for self-assessment of educational achievements of primary school students with a PO in mathematics lessons, the pedagogical criteria of which are: consistency, accessibility and continuity, has not received sufficient theoretical justification. The selection and

systematization of tasks that are implemented in the didactic materials created and tested during the study are insufficiently reasoned and justified. It is not sufficiently substantiated that this system of special tasks contributes to the development of adequate self-esteem of both normotypic and students with mental retardation.

On the basis of the dissertation work of Kalykbaeva Almagul Zhakanovna protected in open access on the topic "Organization of self-assessment of educational achievements of students with mental retardation in inclusive education" and according to the results of secret voting, send the dissertation work of Kalykbaeva Almagul Zhakanovna for revision.

The hearing of the final version of the dissertation and responses to comments took place on September 30, 2022.

According to the dissertation of *Dyusenbayeva Bibigul Amangeldinovna*: 1) analysis of the topics of the reviewed works;

The topic of the dissertation is the preparation of a special teacher to work in an inclusive education.

The defense took place on June 13, 2022.

New and reliable results were obtained in the work:

- 1. The definition of the essence of the concept "preparation of a special teacher for work in inclusive education" is substantiated and given.
- 2. The current trends in the development of foreign and Kazakh pedagogical education in the preparation of a special teacher are determined.
- 3. An approximate list of professional competencies of special teachers at different levels of qualification in ORC has been developed as a goal of professional training (graduate model).
- **4.** An organizational and pedagogical model of training a special teacher to work in inclusive education has been developed, which is a purposeful, complex and consistent activity and includes a description of the purpose, methodological foundations, principles, types of readiness, components of teacher training, pedagogical conditions and the result of training.

3)analysis of the level of implementation of the results of dissertations in practice

The practical significance of the research lies in the selection of diagnostic tools to study the state of readiness of special teachers to work in inclusive education; the development of an organizational and pedagogical model of training a special teacher to work in inclusive education, in the development of a Draft Card of the profession "Special teacher"; in the development and implementation in the educational process of textbooks for universities "Alemdegi arrayy zhane inclusivti bilim berudi damytu", "Development of special and inclusive education in the world" and a number of educational and methodological complexes for students of 1,2 courses in the disciplines: "Introduction to the specialty", "Fundamentals of volunteer activity".

Based on the dissertation work of Dyusenbayeva Bibigul Amangeldinovna protected in the open access on the topic "Preparation of a special teacher for work in inclusive education" and based on the results of a secret ballot, a decision was made: send for revision.

The hearing of the final version of the dissertation and responses to comments took place on September 30, 2022.
