**3. A brief analysis of the dissertations considered by the council during the reporting year, highlighting the following sections:**

According to the dissertation of *Bekeeva Nuraisha Zhusupovna*:

1) *analysis of the topics of the reviewed works;*

The topic of the dissertation is "Methods of developing students' professional communication skills when teaching the Kazakh language"

*Specialty:* 6D0101700 – "Kazakh language and literature "

*Scientific consultants* – Professor Orazbaeva F.Sh., University professor, doctor Chetin Pekajar

The defense took place on September 29, 2022.

*New and reliable results were obtained in the work:*

- a scientific and methodological system has been developed to improve students' professional communication skills at the level of a professional and business language personality;

- based on materials tested at the world level, situational and activity orientation of language topics and speech tasks used in the development of professional communication skills;

- the methodology of developing professional communication skills in language teaching has developed a spiritually rich model of a professional personality based on the concept of Abai "tolyk adam" and the teachings of



Confucius "virtuous man" and the use of national values and phraseological expressions in business discourse;

- methods of development of professional communicative skills of students in teaching the Kazakh language a new universal technology of interactive network learning, used in modern online and offline learning, is presented.

2) *the connection of the topics of dissertations with the directions of science development, which were formed by the Higher Scientific and Technical Commission under the Government of the Republic of Kazakhstan in accordance with paragraph 3 of Article 18 of the Law "On Science" and (or) state programs;*

The main idea of the study is that in accordance with the Order of the Minister of Education and Science of the Republic of Kazakhstan dated October 31, 2018 №604 in accordance with the state mandatory standard of education of all levels of education of the Republic of Kazakhstan and the Decree of the Government of the Republic of Kazakhstan dated October 12, 2021 № 746 in the tasks of implementing the state program for the development of education and science under the national project "Bilimdi ult" quality education corresponds to the priority directions of development.

3) *analysis of the level of implementation of the results of dissertations in practice*

In teaching the Kazakh language, it can be recommended for use in the educational process of training future specialists in the field of the Kazakh language for the formation and development of professional and linguistic communicative competence, skills, activity, formation of critical attitude, the main factor of student creativity - educational and cognitive motivation that satisfies his needs, independent decisions and beliefs.

*The defense took place on November 10, 2022.*

*New and reliable results were obtained in the work:*

- the scientific, theoretical and methodological foundations of mythical motifs in Kazakh stories are determined;

- the philosophical, psychological, pedagogical foundations of teaching mythical motives are determined;

-the educational and methodological complex of the course "mythical motifs in modern Kazakh stories and their teaching" has been prepared and developed for use in the training of specialists of the Kazakh language and literature;

- the types of innovative technologies and methods used in the training of mythical creatures are presented;



- formative, control stages of experimental work have been carried out. The significance of the results obtained lies in the fact that the results of the experimental study are analyzed, generalized and refined.

2) *the connection of the topics of dissertations with the directions of science development, which were formed by the Higher Scientific and Technical Commission under the Government of the Republic of Kazakhstan in accordance with paragraph 3 of Article 18 of the Law "On Science" and (or) state programs;*

The Law of the Republic of Kazakhstan "On Education", the Law of the Republic of Kazakhstan "On the status of a teacher", the annual Messages of the Head of State of the Republic of Kazakhstan Kassym-Jomart Tokayev to the people of Kazakhstan have been implemented, which fully allow our subjective ideas to enter into action in the educational business.
