According to the thesis of Kozhakhmetova Asel Sabyrbekovna:

1) Analysis of the topics of the considered works;

The topic of the dissertation is "Representation of axiological semantics in the language of the Kazakh press"

Specialty: 6D021300 - "Linguistics"

Scientific consultants - Doctor of Philological Sciences, Professor M.Sh.Musatayeva, Doctor of Philological Sciences, Professor A.K.Kiklevich. The defense took place on April 4, 2022.

The following new and reliable results were obtained in the work:

- defined the role of the media as a factor influencing the formation and functioning of values in the conditions of modern Kazakhstan;
- linguistic means used in the media to represent the values «отбасы / семья», «келісім / согласие», «отансүйгіштік / патриотизм» in the Kazakh and Russian-language press of Kazakhstan were identified and analyzed;
- a comparative and interpretive analysis of the representatives «отбасы / семья», «келісім / согласие», «отансүйгіштік / патриотизм» were carried out according to the media materials;
- an associative experiment was carried out in order to establish a correlation between the values «отбасы / семья», «келісім / согласие», «отансуйгіштік / патриотизм», explicated in the language of the press and in the modern everyday

consciousness of the respondents. Experimentally, the main components of the values «отбасы / семья», «келісім / согласие», «отансүйгіштік / патриотизм» are determined.

The defense took place on October 26, 2022.

The following new and reliable results were obtained in the work:

- for the first time in domestic (Kazakh) and foreign linguistics (French), on the material of modern media discourse, a way of forming the image of the concept by describing the concept of "business woman" is comprehensively presented;
- the main ways of representing the concept of "business woman" in the language picture of the world on the material of the Kazakh and French media discourse are determined;
- the main cognitive stereotypes are characterized, structuring this concept in the linguistic consciousness of the representatives of the two countries, defining the basic ideas about a business woman in the Kazakh and French linguistic cultures;
- Structural and content units of the concept "business woman" are revealed.

2) Connection of the topics of dissertations with the directions of development of science, which are formed by the Higher Scientific and Technical Commission under the Government of the Republic of Kazakhstan in accordance with paragraph 3 of Article 18 of the Law "On Science" and (or) state programs;

The main idea of the research is media linguistics, socio-linguistics, linguo-culturology, intercultural communication, lexicology of the Kazakh and French languages. The main practical conclusions, results and linguistic materials of the dissertation (texts that form the basis of media discourse, materials describing the components of the concept) can be used in the training of specialists in the learning process. Complies with the Law of the Republic of Kazakhstan "On Education" regarding the requirements aimed at solving the problems specified in the state compulsory education standards at all levels of the general educational process, approved by the Minister of Education and Science of the Republic of Kazakhstan, and other state regulatory legal documents, in connection with the development of the education system and improving the quality of training of competitive specialists. The following new and reliable results were obtained in the work:

- in Kazakh linguistics, for the first time, the semantic-content and cultural-cognitive aspects of the concepts of "duty and obligation" in the context of language and religion are considered in a comprehensive and separate way;
- the concepts of "duty and obligation" in the context of language and religion are analyzed in the ethno-linguistic and linguo-cognitive aspect, the features of their lexical-semantic content are determined;
- the ethno-culturological, ethno-linguistic features of the concepts "duty and duty" in the ethnic knowledge of the Kazakh people are revealed and the

spiritual-cultural, humanistic-moral, axiological qualitative characteristics of the concepts "duty and obligation" in language texts are shown;

 Spiritual-cultural, humanistic-moral, suggestive, structural-content models and stylistic-pragmatic features of the concepts of "duty and obligation" in language and religion are defined.
