The defense took place on September 28, 2023.

The following new and reliable results were obtained in the work:

- The novelty of the first result is that the genesis of the process of formation, creation and artistic development of national-ethnographic values was comprehensively studied;
- The novelty of the second result is that the personality and behavior of the characters of the work are studied in the process of development, the path of growth in the work of art is differentiated, national-ethnographic features are analyzed;
- The novelty of the third result is that the artistic image is the main support of the work, its personality as a participant in the main plot of the work was considered based on the text comprehensively;

- The novelty of the fourth result is that the characters of the work, their image and behavior in the story are considered in a new way in the dissertation research in the context of national-ethnographic values.

Defense took place on December 27, 2023.

The following new and reliable results were obtained in the work:

- the first result is new, valuable conclusions were made about the writer's artistic and aesthetic pursuits in his prose works;
- the second result is new, comprehensive psychoanalytic analysis that proves the writer's stylistic searches and skill in depicting the inner twists of human soul;
- the third result is new, because the writer Zhumeken Nazhimedenov's contribution to Kazakh prose was defined on the basis of specific theoretical and literary materials;
- the fourth result is new, because the Writer's prose works were studied for the first time, systematized by the genres of story and novel;
- 2) The connection of the topic of the dissertation with the directions of the development of science, which were formed by the Higher Scientific and Technical Commission under the Government of the Republic of Kazakhstan in accordance with paragraph 3 of Article 18 of the Law "On Science" and (or) state programs

3) analysis of the level of application of dissertation results in practice.

Teaching the peculiarities of Kazakh prose to the students of the Faculty of Philology of the Higher School will allow them to comprehensively develop a future specialist, improve the quality of education, teach them to appreciate national values and noble heritage and develop their intellectual potential. The scientific results of the dissertation work, developed during the research work, can be used as an auxiliary aid in such disciplines as "History of Kazakh Literature", "Kazakh Literature of 1960-1990 years", "History of the Kazakh novel".
